Project Code Additions

• 61Y9X – State – Higher Education Adult Part-Time Student (HEAPS)

*WV Code 18C-5-7 provides reimbursed grant funding primarily for non-traditional college students through the WV Higher Education Policy Commission (WVHEPC).

*All full/part-time enrollment must be submitted to the WVDE through WVEIS. An official report is submitted from WVDE to WVHEPC to verify program offerings.



Revenue Source Code Additions

• 03913 – Public Charter School State Aid Allocation

*Commitments or payments made by the State directly to public charter schools for the benefit of the LEA to distribute state aid directly related to students physically located in the school district.

Object Code Amendments

- 11 Professional Personnel
 - 111 Regular. Compensation paid to professional personnel of the LEA who have regular positions throughout the employment term for the performance of their normal duties. (This includes permanent substitutes under position codes 230, 231 and 232.)

- 13 Professional Personnel Day-to-Day Substitutes
- 14 Service Personnel Day-to-Day Substitutes

*Object codes in these sections were clarified to be specifically used for day-to-day substitute compensation.

 - 151 Temporary/Part-time Professional
 - 152 Temporary/Part-time Service

*Temporary/Part-time Service (OBJ 152) used to be OBJ 161. Now it's moved under 15X to make room for new coding for substitutes filling vacant positions compensation.
