ORDER AND NOTICE FOR ADDITIONAL COUNTY LEVY TO VOTERS OF CALHOUN COUNTY

That at a regular meeting of the Board of Education of the County of Calhoun, State of West Virginia held on the 19th day of August of 2020, as provided by law, the following order was made and entered of record, to wit:

The Board of Education of the County of Calhoun, being of the opinion that the maximum levies for current expenses authorized by Article 8, Chapter 11 of the Code of West Virginia, as amended, will not provide sufficient funds for the payment of current expenses of the Board of Education, including expenditures for the purposes hereinafter set forth, and that an election shall be held to increase such levies under the provisions of Section 16, Article 8, Chapter 11 of the Code, as amended, it is hereby ORDERED:

- 1. That the purpose for which additional funds are needed is to provide payment of the expense of operating the Calhoun County Library and supporting its role in education of Calhoun County.
- 2. That the approximate amount of each purpose is as follows: Calhoun County Library \$50,300.
- 3. That the annual approximately amount for said purpose is \$50,300. after estimated tax discounts, exonerations and delinquencies, and the total amount for the five year levy is \$251,500.
- **4.** That the separate and aggregate assessed valuation of class of taxable property within the County of Calhoun is as follows:

Class I	\$ 00.
Class II	101,752,797.
Class III	131,854,443.
Class IV	<u>11,474,360.</u>
Aggregate	\$ 245,081,600.

5. That the additional levy rate in cents per one hundred dollars of Assessed valuation on each class of property is as follows:

Class I	0.714
Class II	1.428
Class III	2.856
Class IV	2.856

- **6.** That the proposed years to which the additional levy shall apply on the Fiscal Years beginning July 1, 2022, July 1, 2023, July 1, 2024, July 2025 and July 2026.
- 7. That the Board of Education will not issue bonds upon approval of the proposed increased levy.
- 8. That the question of such additional levy shall be submitted to a vote at an election to be held on the 3rd day of November, 2020.
- 9. The notice calling such election shall be given by the publication of this order at least once each week for two successive weeks before said election in two newspapers of opposite politics and general circulation in the territory in which the election is held. If there is only one newspaper published in the county, said publication shall apply as far as they are practicable, except that a separate ballot shall be used at such election when held in connection with any other election.
- 10. That the ballot to be used at such election shall be in form as follows:

CALHOUN COUNTY LIBRARY LEVY BALLOT

"Election to authorize additional levies for the fiscal years beginning July 1, 2022, July 1, 2023; July 1, 2024; July 1. 2025 and July 1, 2026 for the purpose of providing operating money for the Calhoun County Library, according to the order of the Board of Education entered on the 19th day of August 2020.

The additional levy shall be on Class I property .714 centers per \$100.00 of assessed value; on Class II property 1.428 cents per \$100.00 of assessed value; on Class III property 2.856 cents per \$100.00 of assessed value; and on Class IV property 2.856 cents per \$100.00 of assessed value."
